BEAU SMOKE sped to the early lead, set the pace off the rail, angled in on the turn, kicked clear, opened up in the stretch and just held under urging. CANDY PULL stalked inside, came out into the stretch and surged late to just miss. LEMON settled outside a rival then off the rail, went four wide into and on the turn and three deep into the stretch and bested the others. MAGIC MIKE was in a good position stalking the pace between horses on the backstretch and turn and weakened. TEMPTING TREASURES also stalked between horses, dropped back and angled in on the turn, came out into the stretch and lacked the needed response. SAXOPHONE four wide early, tracked the winner outside then off the rail on the turn and weakened in the stretch. WARREN'S OPERATOR bobbled at the start, chased between horses, angled in leaving the turn and had little left for the stretch.
