Footnotes

CRIB KICKER raced three wide on the first turn, prompted the pace on the outside, drew even leaving the backstretch, vied outside on the far turn, kicked clear in upper stretch and held well under strong urging. WHEN THE CATS AWAY bumped with a rival just after the start, was rated between rivals while rank, settled a bit with a half-mile to run, waited behind rivals on the far turn, swung four wide into the stretch and finished willingly for the place. PARTY OF ONE was well placed on the inside, waited behind rivals on the far turn and also finished willingly but lacked the needed kick. SOFT N' LOUD was bumped at the start, lagged at the rear of the field, moved out in the stretch and improved position. SPRUCE LIMERICK broke outward and bumped with a rival, raced three wide on the first turn, tracked the pace on the outside, ranged up while three wide on the far turn, made a bid passing the quarter-pole but came up empty and gave way. VELVET ACCOUNT bumped with a rival just after the start, was well rated while setting the pace, lost the lead on the far turn, dropped out near the quarter-pole and faded. HOLLYE LYNNE settled off the pace, saved ground on both turns, moved out in upper stretch and failed to threaten. (Rail at 20 Feet)
